ORDINANCE NO. 17-10

AN ORDINANCE AMENDING THE FY2017 BUDGET FOR THE VILLAGE OF COAL CITY

WHEREAS, the Village of Coal City (“Village”) is an Illinois non-home rule municipal corporation, organized and operating pursuant to the Constitution and laws of the State of Illinois; and

WHEREAS, the Village has an approved FY17 Annual Budget for the fiscal year commencing May 1, 2016 and ending April 30, 2017 (the “Budget”); and

WHEREAS, certain expenditures planned by the Board of Trustees and unforeseen costs were not included within the Budget but are necessary to maintain the infrastructure and municipal services for Village residents; and

WHEREAS, the Village is authorized by 65 ILCS 5/8-2-9.6 to revise the Budget by a two-thirds super-majority vote of the Corporate Authorities; and

WHEREAS, the Village desires to amend the as set forth herein; and

WHEREAS, the Corporate Authorities hereby find and determine that sufficient funds are available to effectuate the purpose of the revision(s) herein set forth; and

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Coal City, Counties of Will and Grundy, Illinois, as follows:

SECTION 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

SECTION 2. Budget Amendment. The FY2017 Budget (and consequently total governmental expenditures) shall be amended as set forth in Exhibit A, which is, by this reference, made a part of this Ordinance. The Village Administrator is hereby authorized and directed to undertake such other and further tasks as may be necessary to effectuate the purposes of this Ordinance.

SECTION 3. Repealer.


All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4. Saving Clause. If any section, paragraph, clause, or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance, which are hereby declared to be separable.


SECTION 5. Effectiveness. This Ordinance shall be in full force and effect from and after its passage, approval, and publication in the manner provided by law.
