AN ORDINANCE AUTHORIZING THE BORROWING OF FUNDS FROM CENTRUE BANK FOR THE GENERAL MUNICIPAL CORPORATE PURPOSES OF THE VILLAGE OF COAL CITY AND ESTABLISHING REPAYMENT SCHEDULE FOR OUTSTANDING PRINCIPAL

WHEREAS, the Village of Coal City ("Village") is an Illinois non-home rule municipal corporation, organized and operating pursuant to the Constitution and laws of the State of Illinois; and

WHEREAS, pursuant to Section 8-1-3.1 of the Illinois Municipal Code, 65 ILCS 5/8-1-3.1, the Village is authorized to borrow money from a bank or other financial institution, provided that such money shall be repaid within ten (10) years from the time the money is borrowed; and

WHEREAS, the Village previously enacted Ordinance No. 13-11 on May 28, 2013, which authorized the Village to borrow up to One Million Dollars and No/100 Cents (\$1,000,000.00) [the "Loan"] in order to fund the acquisition of certain equipment and vehicles and the completion of certain capital improvement projects ("Contemplated Public Expenditures") pursuant to the terms and conditions of a promissory note governing the Village's obligations under said Loan; and

WHEREAS, the aforesaid Contemplated Public Expenditures are each in furtherance of a valid and proper public and corporate purpose; and

WHEREAS, the Corporate Authorities have previously individually authorized the acquisition of (i) a pick-up truck for the use and benefit of the Department of Public Works, (ii) squad cars with equipment installed therein in accordance with the specifications of the Police Department, and (iii) a mini-excavator for the Public Works Department (cumulatively, the "Actual Expenditures"); and

WHEREAS, the Actual Expenditures were funded with Loan proceeds in the cumulative principal amount of \$183,676.41; and

WHEREAS, the Corporate Authorities remain desirous of completing the remaining Contemplated Public Expenditures within twelve (12) months from the date of this Ordinance; and

WHEREAS, the Corporate Authorities of the Village have determined that it is advisable, necessary and in the best interest of the Village and its residents to authorize the borrowing of funds to complete the remaining Contemplated Public Expenditures, each of which is in furtherance of the general public and corporate purposes of the Village; and

WHEREAS, the Village therefore wishes to authorize the renewal of the Loan by authorizing execution of a promissory note in the amount of the previously-authorized Loan less the outstanding principal on that Loan utilized by the Village to make the Actual Expenditures;

WHEREAS, the Village wishes to also agree to repayment terms and conditions for the currently-outstanding principal amount of \$183,676.41; and

WHEREAS, Section 8-1-3.1 of the Illinois Municipal Code, 65 ILCS 5/8-1-3.1, further provides "[t]he promissory note or other debt instrument shall be authorized by an ordinance passed by the corporate authorities and shall be valid whether or not an appropriation with respect to that ordinance is included in any annual or supplemental appropriation adopted by the corporate authorities"; and

WHEREAS, a copy of the promissory note setting forth its terms and conditions is attached hereto, incorporated herein, and made a part hereof as "Exhibit A" (the "Promissory Note");

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Coal City, Counties of Will and Grundy, Illinois, as follows:

SECTION 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

SECTION 2. Title. This Ordinance shall be known and may hereafter be referred to as

An Ordinance Approving 2014 Centrue Bank Loan for Equipment Purchases.

SECTION 3. Authorization of Loan.

- **A.** The President and the Board of Trustees of the Village of Coal City do hereby authorize the Village to borrow funds, as empowered by 65 ILCS 5/8-1-3.1, upon the terms and conditions as set out in the promissory note in favor of Centrue Bank, substantially in the form attached hereto and made a part hereof as Exhibit A ("Promissory Note").
- B. The Village President is authorized and directed to execute the Promissory Note, and to execute such other documents or perform such acts as are necessary to borrow a sum not to exceed the lesser of (i) Eight Hundred Sixteen Thousand Three Hundred Twenty Three Dollars and 60/100 Cents (\$816,323.60) and (ii) an amount, when aggregated with the existing indebtedness of the Village, that does not exceed the debt limitation provided in Section 8-5-1 of the Illinois Municipal Code (65 ILCS 5/8-5-1), all in accordance with the interest rate and other terms and conditions as are set forth in the Promissory Note or a promissory note substantially in the form of the Promissory Note as may be reviewed and approved by the Village Attorney.

- C. The Village Clerk is authorized and directed to attest, countersign and affix the seal of the Village of Coal City to a Promissory Note substantially in the form attached hereto, and any and all other documents necessary to carry out and give effect to the purpose and intent of this Ordinance. The Corporate Authorities hereby authorize the Village to borrow said funds by means of a lump sum loan, in installments, or by any means authorized by law and as specified in the Promissory Note.
- D. The Village President, Village Clerk, Village Administrator and Village Attorney are hereby authorized and directed to do all things necessary, essential or convenient to carry out and give effect to the purpose and intent of this Ordinance.
- E. All acts and doings of the officials of the Village, past, present and future which are in conformity with the purpose and intent of this Ordinance, are hereby, in all respects, ratified, approved, authorized and confirmed.

SECTION 4. Authorization of Repayment Schedule for Outstanding Principal on Loan.

- A. The President and the Board of Trustees of the Village of Coal City do hereby acknowledge and agree that, at various times during the Village's current fiscal year, the Village has borrowed an aggregate principal amount of \$183,676.41 from Centrue Bank under the Loan in order to acquire the Actual Expenditures, as follows:
 - 1. Pick-up Truck \$17,921.30 on 19, 3013 [date] ["Pickup Expense"]
 - 2. Squad cars and equipment installation therein \$104,855.11 on May 6,2013 [date] ["Police Car Expense"]
 - 3. Mini-Excavator \$60,900.00 on Feb 35, 2013 [date] ["Excavator Expense"]
- **B.** The President and Clerk of the Village of Coal City are authorized to execute and attest any and all legal documents necessary to provide for a repayment schedule of

principal and interest on the Actual Expenditures in accordance with the form, terms and conditions substantially in the form set forth in that certain Outstanding Principal Repayment Schedule attached hereto as Exhibit B. The Outstanding Principal Repayment Schedule shall provide for (i) once-annual payments by the Village to Centrue Bank beginning in March, 2015, (ii) a two-year term of repayment following the initial payment for the Pickup Expense, (iii) a three-year term of repayment commencing with the initial payment for the Police Car Expense, (iv) a four-year term of repayment commencing with the initial payment for the Excavator Expense, (v) an interest rate of 2.790% per annum calculated from the date of each respective advance identified in Subsection 4(A); and (vi) prepayment in whole or in part by the Village without penalty.

- C. The Village President, Village Clerk, Village Administrator and Village Attorney are hereby authorized and directed to do all things necessary, essential or convenient to carry out and give effect to the purpose and intent of this Ordinance.
- **D.** All acts and doings of the officials of the Village, past, present and future which are in conformity with the purpose and intent of this Ordinance, are hereby, in all respects, ratified, approved, authorized and confirmed.

SECTION 5. Resolution of Conflicts. All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 6. Saving Clause. If any section, paragraph, clause, or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance, which are hereby declared to be separable.

SECTION 7. Effectiveness. This Ordinance shall be in full force and effect from and after its passage, approval, and publication in the manner provided by law.

PROMISE TO PAY. Village of Coal City, Illinois ("Borrower") promises to pay to Centrue Bank ("Lender"), or order, in lawful money of the United States of America, the principal amount of Eight Hundred Sixteen Thousand Three Hundred Twenty-three & 60/100 Dollars (\$816,323.60) or so much as may be outstanding, together with interest on the unpaid outstanding principal balance of each advance, calculated as described in the "INTEREST CALCULATION METHOD" paragraph using an interest rate of 2.790%. Interest shall be calculated from the date of each advance until repayment of each advance. The interest rate may change under the terms and conditions of the "INTEREST AFTER DEFAULT" section.

PAYMENT. Borrower will pay this loan in one payment of all outstanding principal plus all accrued unpaid interest on March 25, 2015. In addition, Borrower will pay regular monthly payments of all accrued unpaid interest due as of each payment date, beginning April 25, 2014, with all subsequent interest payments to be due on the same day of each month after that. Unless otherwise agreed or required by applicable law, payments will be applied first to any accrued unpaid interest; then to principal; and then to any late charges. Borrower will pay Lender at Lender's address shown above or at such other place as Lender may designate in writing.

INTEREST CALCULATION METHOD. Interest on this Note is computed on a 365/360 basis; that is, by applying the ratio of the interest rate over a year of 360 days, multiplied by the outstanding principal balance, multiplied by the actual number of days the principal balance is outstanding. All interest payable under this Note is computed using this method.

PREPAYMENT. Borrower may pay without penalty all or a portion of the amount owed earlier than it is due. Early payments will not, unless agreed to by Lender in writing, relieve Borrower of Borrower's obligation to continue to make payments of accrued unpaid interest. Rather, early payments will reduce the principal balance due. Borrower agrees not to send Lender payments marked "paid in full", "without recourse", or similar language. If Borrower sends such a payment, Lender may accept it without losing any of Lender's rights under this Note, and Borrower will remain obligated to pay any further amount owed to Lender. All written communications concerning disputed amounts, including any check or other payment instrument that indicates that the payment constitutes "payment in full" of the amount owed or that is tendered with other conditions or limitations or as full satisfaction of a disputed amount must be mailed or delivered to: Centrue Bank, Coal City Branch, 660 S Broadway, Coal City, IL 60416.

LATE CHARGE. If a payment is 10 days or more late, Borrower will be charged 5.000% of the regularly scheduled payment or \$10.00, whichever is greater.

INTEREST AFTER DEFAULT. Upon default, including failure to pay upon final maturity, the interest rate on this Note shall be increased to 12.500%. However, in no event will the interest rate exceed the maximum interest rate limitations under applicable law.

DEFAULT. Each of the following shall constitute an event of default ("Event of Default") under this Note:

Payment Default. Borrower fails to make any payment when due under this Note.

Other Defaults. Borrower fails to comply with or to perform any other term, obligation, covenant or condition contained in this Note or in any of the related documents or to comply with or to perform any term, obligation, covenant or condition contained in any other agreement between Lender and Borrower.

Default in Favor of Third Parties. Borrower or any Grantor defaults under any loan, extension of credit, security agreement, purchase or sales agreement, or any other agreement, in favor of any other creditor or person that may materially affect any of Borrower's property or Borrower's ability to repay this Note or perform Borrower's obligations under this Note or any of the related documents.

False Statements. Any warranty, representation or statement made or furnished to Lender by Borrower or on Borrower's behalf under this Note or the related documents is false or misleading in any material respect, either now or at the time made or furnished or becomes false or misleading at any time thereafter.

Death or insolvency. The death of Borrower or the dissolution or termination of Borrower's existence as a going business, the insolvency of Borrower, the appointment of a receiver for any part of Borrower's property, any assignment for the benefit of creditors, any type of creditor workout, or the commencement of any proceeding under any bankruptcy or insolvency laws by or against Borrower.

Creditor or Forfeiture Proceedings. Commencement of foreclosure or forfeiture proceedings, whether by judicial proceeding, self-help, repossession or any other method, by any creditor of Borrower or by any governmental agency against any collateral securing the loan. This includes a garnishment of any of Borrower's accounts, including deposit accounts, with Lender. However, this Event of Default shall not apply if there is a good faith dispute by Borrower as to the validity or reasonableness of the claim which is the basis of the creditor or forfeiture proceeding and fi Borrower gives Lender written notice of the creditor or forfeiture proceeding and deposits with Lender monies or a surety bond for the creditor or forfeiture proceeding, in an amount determined by Lender, in its sole discretion, as being an adequate reserve or bond for the dispute.

Events Affecting Guarantor. Any of the preceding events occurs with respect to any guarantor, endorser, surety, or accommodation party of any of the indebtedness or any guarantor, endorser, surety, or accommodation party dies or becomes incompetent, or revokes or disputes the validity of, or liability under, any guaranty of the indebtedness evidenced by this Note.

Adverse Change. A material adverse change occurs in Borrower's financial condition, or Lender believes the prospect of payment or performance of this Note is impaired.

Insecurity. Lender in good faith believes itself insecure.

Cure Provisions. If any default, other than a default in payment is curable and if Borrower has not been given a notice of a breach of the same provision of this Note within the preceding twelve (12) months, it may be cured if Borrower, after Lender sends written notice to Borrower demanding cure of such default: (1) cures the default within thirty (30) days; or (2) if the cure requires more than thirty (30) days, immediately initiates steps which Lender deems in Lender's sole discretion to be sufficient to cure the default and thereafter continues and completes all reasonable and necessary steps sufficient to produce compliance as soon as reasonably practical.

LENDER'S RIGHTS. Upon default, Lender may declare the entire unpaid principal balance under this Note and all accrued unpaid interest immediately due, and then Borrower will pay that amount.

ATTORNEYS' FEES; EXPENSES. Lender may hire or pay someone else to help collect this Note if Borrower does not pay. Borrower will pay Lender that amount. This includes, subject to any limits under applicable law, Lender's attorneys' fees and Lender's legal expenses, whether or not there is a lawsuit, including attorneys' fees, expenses for bankruptcy proceedings (including efforts to modify or vacate any automatic stay or injunction), and appeals. If not prohibited by applicable law, Borrower also will pay any court costs, in addition to all other sums provided by law.

JURY WAIVER. Lender and Borrower hereby waive the right to any jury trial in any action, proceeding, or counterclaim brought by either Lender or Borrower against the other.

GOVERNING LAW. This Note will be governed by federal law applicable to Lender and, to the extent not preempted by federal law, the laws of the State of Illinois without regard to its conflicts of law provisions. This Note has been accepted by Lender in the State of Illinois.

CHOICE OF VENUE. If there is a lawsuit, Borrower agrees upon Lender's request to submit to the jurisdiction of the courts of LaSalle County, State of Illinois.

CONFESSION OF JUDGMENT. Borrower hereby irrevocably authorizes and empowers any attorney-at-law to appear in any court of record and to confess judgment against Borrower for the unpaid amount of this Note as evidenced by an affidavit signed by an officer of Lender setting forth the amount then due, attorneys' fees plus costs of suit, and to release all errors, and waive all rights of appeal. If a copy of this Note, verified by an affidavit, shall have been filed in the proceeding, it will not be necessary to file the original as a warrant of attorney. Borrower waives the right to any stay of execution and the benefit of all exemption laws now or hereafter in effect. No single exercise of the foregoing warrant and power to confess judgment will be deemed to exhaust the power, whether or not any such exercise shall be held by any court to be invalid, voidable, or void; but the power will continue undiminished and may be exercised from time to time as Lender may elect until all amounts owing on this Note have been paid in full. Borrower hereby waives and releases any and all claims or causes of action which Borrower might have against any attorney acting under the terms of authority which Borrower has granted herein arising out of or connected with the confession of judgment hereunder.

RIGHT OF SETOFF. To the extent permitted by applicable law, Lender reserves a right of setoff in all Borrower's accounts with Lender (whether checking, savings, or some other account). This includes all accounts Borrower holds jointly with someone else and all accounts Borrower may open in the future. However, this does not include any IRA or Keogh accounts, or any trust accounts for which setoff would be prohibited by law. Borrower authorizes Lender, to the extent permitted by applicable law, to charge or setoff all sums owing on the debt against any and all such accounts, and, at Lender's option, to administratively freeze all such accounts to allow Lender to protect Lender's charge and setoff rights provided in this paragraph.

LINE OF CREDIT. This Note evidences a straight line of credit. Once the total amount of principal has been advanced, Borrower is not entitled to further loan advances. Advances under this Note may be requested either orally or in writing by Borrower or as provided in this paragraph. Lender may, but need not, require that all oral requests be confirmed in writing. All communications, instructions, or directions by telephone or otherwise to Lender are to be directed to Lender's office shown above. Borrower agrees to be liable for all sums either: (A) advanced in accordance with the instructions of an authorized person or (B) credited to any of Borrower's accounts with Lender. The unpaid principal balance owing on this Note at any time may be evidenced by endorsements on this Note or by Lender's internal records, including daily computer print-outs. Lender will have no obligation to advance funds under this Note if: (A) Borrower or any guarantor is in default under the terms of this Note or any agreement that Borrower or any guarantor has with Lender, including any agreement made in connection with the signing of this Note; (B) Borrower or any guarantor ceases doing business or is insolvent; (C) any guarantor seeks, claims or otherwise attempts to limit, modify or revoke such guarantor's guarantee of this Note or any other loan with Lender; (D) Borrower has applied funds provided pursuant to this Note for purposes other than those authorized by Lender; or (E) Lender in good faith believes itself insecure.

ERRORS AND OMISSIONS. If requested by Lender, Borrower agrees to fully cooperate and adjust for clerical errors any or all closing documents if deemed necessary or desirable in the reasonable discretion of Lender. Borrower agrees to comply with the noted request within 30 days from date of mailing such request. Borrower further agrees to assume all costs including by way of illustration and not limitation, actual expenses and legal fees for failing to reasonably comply with your request in the above noted time period.

FINANCIAL REPORTS. Borrower agrees to furnish Lender with the following:

Tax Returns. As soon as available, but in no event later than 30 (thirty) days after the applicable filing date for the tax reporting period ended, Federal and other governmental tax returns.

Annual Statements. If Borrower is an entity, as soon as available, but in no event later than May 31st after the end of each fiscal year, Borrower's balance sheet and income statement for the year ended, audited by a certified public accountant satisfactory to Lender.

Personal Financial Statement. If Borrower is a natural person, a current detailed personal financial statement in a form acceptable to Lender no less than annually.

Borrower will provide any additional information and statements, as Lender may request from time to time or as disclosed in a Business Loan

SECURITY INTEREST IN DEPOSIT ACCOUNTS. To secure (A) payment of the Note and any other loans, indebtedness or obligations Borrower may now or at any time in the future owe Lender and (B) the performance of Borrower's promises and undertakings hereunder, Borrower grants to Lender a security interest in all of Borrower's deposit accounts.

ADDITIONAL COLLATERAL. Borrower acknowledges that in addition to the Collateral described in any security instruments prepared together with this Note, Property given by any Borrower or Grantor which may secure other loans with Lender may also secure Borrower's obligation under this Loan.

PRIOR NOTE. A Promissory Note No. 2013000871 dated June 13, 2013, in the original principal amount of \$1,000,000.00.

SUCCESSOR INTERESTS. The terms of this Note shall be binding upon Borrower, and upon Borrower's heirs, personal representatives, successors and assigns, and shall inure to the benefit of Lender and its successors and assigns.

GENERAL PROVISIONS. If any part of this Note cannot be enforced, this fact will not affect the rest of the Note. Lender may delay or forgo enforcing any of its rights or remedies under this Note without losing them. Borrower and any other person who signs, guarantees or endorses this Note, to the extent allowed by law, waive presentment, demand for payment, and notice of dishonor. Upon any change in the terms of this Note, and unless otherwise expressly stated in writing, no party who signs this Note, whether as maker, guarantor, accommodation maker or endorser, shall be released from liability. All such parties agree that Lender may renew or extend (repeatedly and for any length of time) this loan or release any party or guarantor or collateral; or impair, fail to realize upon or perfect Lender's security interest in the collateral; and take any other action deemed necessary by Lender without the consent of or notice to anyone. All such parties also agree that Lender may modify

this loan without the consent of or notice to anyone other than the party with whom the modification is made. The obligations under this Note are joint and several.

PROMISE TO PAY. Village of Coal City, Illinois ("Borrower") promises to pay to Centrue Bank ("Lender"), or order, in lawful money of the United States of America, the principal amount of One Hundred Four Thousand Eight Hundred Fifty-five & 11/100 Dollars (\$104,855.11), together with interest on the unpaid principal balance from March 25, 2014, calculated as described in the "INTEREST CALCULATION METHOD" paragraph using an interest rate of 2.790%, until paid in full. The interest rate may change under the terms and conditions of the "INTEREST AFTER DEFAULT" section.

PAYMENT. Borrower will pay this loan in 2 payments of \$36,949.31 each payment and an irregular last payment estimated at \$36,949.31. Borrower's first payment is due March 25, 2015, and all subsequent payments are due on the same day of each year after that. Borrower's final payment will be due on March 25, 2017, and will be for all principal and all accrued interest not yet paid. Payments include principal and interest. Unless otherwise agreed or required by applicable law, payments will be applied first to any accrued unpaid interest; then to principal; and then to any late charges. Borrower will pay Lender at Lender's address shown above or at such other place as Lender may designate in writing.

INTEREST CALCULATION METHOD.
